The Florida Art Education Association (FAEA) would like to promote its members who are not only educators, but practicing artists as well.

Exhibition

- The FAEA Member Visual Art Digital Exhibition will be shown at the 2010 FAEA Conference in Orlando, on the FAEA website and selected works will be featured in upcoming issues of *Fresh Paint*.
- There will be a reception for the Member Visual Art Digital Exhibition during the FAEA Conference on Saturday, October 16, 2010. The Digital Exhibition will be shown at this time.

Entry Fee and Requirements

- There is a \$5.00 entry fee for each digital image of your artwork you submit. You may submit up to 5 (five) images.
- The entry fee helps cover the cost of jurors and compiling the body of work into a presentation.
- You must be a current FAEA member to enter. Visit www.faea.org to renew or start your membership with FAEA.

Specifications and Forms

- Current FAEA members are eligible to submit up to 5 (five) images (\$5.00 fee per image).
- Members must complete the entry and photographic release forms to be eligible.
- All mediums are accepted.

Awards

- A “Best of Show” award will be given.
- There are no cash awards for this year’s exhibition.

Submission of Artwork

- All submissions must be submitted in the digital format indicated below.
- Up to 5 (five) entries per member will be accepted.
- Entries must include digital artwork in the appropriate format, completed entry form and photographic release form, and the entry fee.
- Submissions must be saved as JPG files (see below for information on format).
- Submissions must be received postmarked no later than August 31, 2010.

JPG files

- JPG should be captured by a 2+ megapixel camera. Set camera for “fine” or “extra fine” resolution not “web” or “normal.”
- Image Print Size: at least 1500 x 2100 pixels.
- Image Quality: 300 dpi.
- File Size: at least one megabyte but no greater than 10 megabytes. (Generally, JPG files at 1500 x 2100 pixels are approximately 4-5 megabytes or less.)
- Entries that are not JPG files will not be accepted.
